1. CALL TO ORDER AND FLAG SALUTE

<u>Chair Sampson</u> called a meeting of the Board of Directors of Astoria School District No. 1C, Clatsop County, to order at 7:30 P.M. on Wednesday, February 10, 2016 in the Astoria School District Boardroom. All present stood for the Pledge of Allegiance.

2. NEW BOARD MEMBER OATH OF OFFICE

<u>Chair Sampson</u> welcomed <u>Mr. Oser</u> to the Board of Directors and led him in the oath of office.

3. ASTORIA MIDDLE SCHOOL PRESENTATION

<u>Vice Principal Hummell-Martin</u> spoke about PBiS and plans to decrease negative behavior and enforce positive behavior in students. She explained how staff acknowledge positive behavior by handing Viking Awards out to students and ways that they teach and reteach students to build a culture that shows this is the kind of school we want to have. <u>Ms. Noack</u>, part of the PBiS team, along with three students from her Leadership class, shared activities that they do throughout the year. <u>Ms. Clay</u> explained how they are engaging parents by inviting them to have lunch at school.

8. REPORTS

A. ADMINISTATIVE REPORT

<u>Principal Gohr</u> reported that Astor had five teachers attend a Struggling Readers Conference.

<u>Principal Ploghoft</u> thanked classified employees and commented that they do whatever we need them to do and we don't pay them enough for their services.

<u>Principal Berger</u> pointed out to the Board the AMS art work displayed in the boardroom. She also shared that AMS has six consistent parents that show up to the PTA meetings and that they will be having a movie night to make funds for AMS.

Ms. Linder reported on Constructive Meaning classes and how successful it has become. She also pointed out that February 29th is the first professional in-service day.

<u>Principal Jackson</u> reported that he was very pleased with leadership and how AHS and the District celebrated a higher graduation rate last year. He also explained how freshman amnesty get an additional two weeks to get a passing grade which helps avoid them getting credit cancer.

He pointed out that he has noticed that engagement and visibility has increased and that the District strives to update the website daily.

B. JF/JFA – STUDENTS RIGHTS AND RESPONSIBILITIES
This policy states that school staff must be provided notice of student's right and responsibilities. The policy reflects the notification of staff members.

<u>DIRECTOR RICKENBACH</u> MADE A MOTION TO APPROVE THE CHANGES FOR POLICY JF/JFA – STUDENTS RIGHTS AND RESPONSIBILITIES AND <u>DIRECTOR LAMAN</u> SECONDED. THE MOTION WAS UNANIMOUSLY CARRIED.

C. JFC - STUDENT CONDUCT AND DISCIPLINE

The policy changes in JFC have to do with requirements of suspending students in grades K-5, notification of parents of student expectations and also school district staff using discipline procedures that are age appropriate and research based.

<u>DIRECTOR HELLIGSO</u> MADE A MOTION TO APPROVE THE CHANGES FOR POLICY JFC – STUDENT CONDUCT AND DISCIPLINE AND <u>DIRECTOR</u> <u>OSER</u> SECONDED. THE MOTION WAS UNANIMOUSLY CARRIED.

D. JFCJ – WEAPONS IN THE SCHOOLS

As per law, this policy implements a destructive device as being a firearm.

<u>DIRECTOR HELLIGSO</u> MADE A MOTION TO APPROVE THE CHANGES FOR POLICY JFCJ – WEAPONS IN THE SCHOOLS AND <u>DIRECTOR</u> <u>RICKENBACH</u> SECONDED. THE MOTION WAS UNANIMOUSLY CARRIED.

E. JG – STUDENT DISCIPLINE

The policy changes in JG have to do with requirements of notifying parents of student expectations and also school district staff using discipline procedures that are age appropriate and research based.

<u>DIRECTOR OSER</u> MADE A MOTION TO APPROVE THE CHANGES FOR POLICY JG – STUDENT DISCIPLINE AND <u>DIRECTOR RICKENBACH</u> SECONDED. THE MOTION WAS UNANIMOUSLY CARRIED.

F. JGD – SUSPENSION

The policy changes in JGD have to do with requirements of notifying parents of student expectations in parent/student handbook and also school district staff using discipline procedures that are age appropriate and research based methods.

<u>DIRECTOR RICKENBACH</u> MADE A MOTION TO APPROVE THE CHANGES FOR POLICY JGD – SUSPENSION AND <u>DIRECTOR HELLIGSO</u> SECONDED. THE MOTION WAS UNANIMOUSLY CARRIED.

G. JGAB – USE OF RESTRAINT AND SECLUSION

Changes to this policy included an additional state report requirements that school districts are required to report annually.

<u>DIRECTOR LAMAN</u> MADE A MOTION TO APPROVE THE CHANGES FOR POLICY JGAB – USE OF RESTRAINT AND SECLUSION AND <u>DIRECTOR</u> <u>OSER</u> SECONDED. THE MOTION WAS UNANIMOUSLY CARRIED.

<u>HELLIGSO</u> AS VICE CHAIR AND <u>DIRECTOR LAMAN</u> SECONDED. THE
MOTION WAS UNANIMOUSLY CARRIED.
